

Medicaid Expansion Enrollment and Eligibility Update: Geographic Distribution of Medicaid Enrollees - Maps

Introduction

The State of Missouri is implementing an expansion of the Medicaid program to include all adults age 19-64 earning up to 138% of the federal poverty line FPL (\$30,305 for a family of three), starting July 1, 2021. Based on an earlier analysis by our research team , the number of new adults projected to enroll in the expansion of Medicaid in Missouri within the first year is 247,500 adults. A recent release of Missouri Governor Parson's budget assumes that the projected enrollment for the Medicaid expansion will be 274,312 adults in the first year. Our original estimate of 247,500 newly enrolled adults is within range of the Governor's projection and will be used for the analyses in this document.


This Fact Sheet outlines the geographic distribution of those 247,500 adults that are expected to enroll during the first year of the expansion, July 2021 to July 2022. The distribution of the new Medicaid enrollees in Missouri is important background information for the State of Missouri, the communities, providers, and other community service organizations as they prepare to serve the newly eligible enrollees. The numbers provided here can be used to help estimate the expected demand for health care services across the State. The Fact Sheet concludes with a description of the data used to compile these estimates, and the methods used.

Geographic Distribution of Expected Medicaid Enrollment in Missouri

Estimated new Medicaid enrollment as a result of Medicaid expansion varies significantly by county and region across the State of Missouri. The maps in Figures 1 and 2 highlight the percentage of each county's population that is expected to enroll in Medicaid as a result of the expansion, as well as the number of new enrollees expected by county. In general, the counties with the greatest percentage of their populations that are expected to enroll in Medicaid are concentrated in rural areas, particularly in the southern half of the state, and the urban core counties. The counties with the largest numbers of new enrollees are in urban areas. There is substantial variation in the percent of the population that is expected to enroll across Missouri counties ranging from a low of 1.6 percent (6,409 enrollees) in St. Charles County to a high of 9.0 percent (2,045 enrollees) in McDonald County. A total of 20 counties did not have estimates included in the map due to the estimated enrollee numbers being too small to be accurately reported. These counties are represented in white in the map and an asterisk on the enrollment table below.



Overall Distribution

These geographic estimates of enrollment are useful in predicting the expected increase in the demand for health care services across the state. As the number of Medicaid enrollees grows the demand for health care services grows, including the demand for providers that accept Medicaid patients. Additional or expanded provider capacity may be needed across Missouri but will likely be essential in high growth areas. Table 1 (below) presents the estimated number of new enrollees by county, the number of current Medicaid enrollees by county, and the estimated percent increase in Medicaid enrollment at the county level. The estimated increase in enrollment statewide is 24.1%, but the expected growth varies by county with the highest growth of 37.6% in Boone County and the lowest growth of 16.0% in Pemiscot County. Providers across Missouri should plan to see an increase in the number of individuals with Medicaid coverage that are seeking health care services.

Data Sources

The 2019 American Community Survey (ACS) 1-year estimates were used to assess the size and composition of the Missouri population eligible for Medicaid as well as the number who would potentially enroll. The ACS dataset was restricted to noninstitutionalized, U.S. citizens under 65-years-old living in households earning at or below 138% FPL. This population was then separated into three categories of current insurance coverage: employer sponsored, marketplace (private non-ESI coverage in the data), and the uninsured. For this analysis, Tricare was included as part of employer sponsored insurance. Individual adults who fell into one of these groupings within the restricted dataset were considered to be the Medicaid eligible population. To estimate the potential Medicaid enrollee population, we assumed distinct take-up rates to apply to each coverage group for the eligible population. These rates were 73% for the uninsured, 10% for those on employer sponsored coverage, and 100% for those on marketplace coverage with incomes from 100-138% FPL. The total estimated enrollee population reflects the totals across these groups. The distribution of enrollees by each county in Missouri was calculated apportioning the revised Medicaid enrollment estimates, using the 2018 Small Area Health Insurance Estimates (SAHIE) and current county population numbers.
