#### 1) Announcements

# 4) HLC response to Interim SLU Report

Steve Sanchez offered the UUCC an update on the Higher Learning Commission's recent (12/18) response to our interim report. HLC notes that SLU has made good progress, but places a lot of emphasis on necessity for Core to move forward at a solid pace, with some elements of a new core being piloted in 2021-22, when the HLC will be on campus for a site visit (either in fall or spring. UUCC will lobby for spring, so that if we pilot in fall 21, we can have some assessment data to show in spring 22).

## 5) Core Design Submission Review

- $\circ$  2/5 2/14: UUCC meets twice a week to review all Core design submissions and identify two ways forward.
- o On 2/14 or 2/19, UUCC will split in two teams, each working on one draft core model
- o A subcommittee of the whole will also be working on a third draft option.

- Deadline is 2/1; proposals will likely come in over the weekend. All submissions will go through Assistant to the Core, who will number and anonymize them before posting them to the UUCC workspace.
- Ellen is working with Debie Lohe in the Reinert center to create a Reader Encounter Form that will help us all do so pre-sorting on our own before coming together to discuss designs together as a group. This will be a document that:
  - 1) Allows us to predigest what we are seeing in advance of our UUCC discussions.
  - 2) Gives us some sorting principles that highlight overlap, divergence, shared features
  - 3) Helps us map submissions to our Core SLO's.
  - 4) Asks us to think both qualitatively and quantitatively, and highlight both presence and absences.
